An initial validation audit was performed March 30 through April 1, 2010, of your facilities at 223 N. Crescent Way, Anaheim, CA 92801 to the requirements of MIL-PRF-31032A with Amendment 1 and your Technical Review Board (TRB) approved Quality Management (QM) Plan. Compliance with these requirements has been successfully demonstrated. Therefore KCA Electronics, Inc. (Anaheim, CA 92801) is considered a certified manufacturer eligible to qualify and supply printed boards to the requirements of MIL-PRF-31032. The effective date of this certification is September 15, 2010. This certification covers the following:

- Quality Management Plan: QSM3000 KCA Quality Manual (latest revision), and QSP-05-05 - TRB Structure & Responsibilities (latest revision).
- Process Flow Documentation Index: QSP-04-02, Document and Data Control (maintained through the KCA Electronics' document control database).
- Process Flow: QSP-08-20, Qualification Testing (latest revision).

This certification gives your TRB the responsibility and flexibility to approve major changes to the MIL-PRF-31032 certified process flow and QM plan with concurrent notification to the qualifying activity (DLA Land & Maritime-VQ), with the following exceptions:

- Test optimization initiatives must be coordinated with DLA Land & Maritime prior to implementation.
- Future qualification actions must be coordinated with DLA Land & Maritime throughout the qualification process.

This certification will normally be valid for two years from the effective date and can only be terminated by written notification from this Center. For the duration of the certification, the manufacturer is subject to periodic reviews by the qualifying activity or its representatives. KCA Electronics, Inc agrees to submit status reports in accordance with its TRB approved QM Plan and MIL-PRF-31032A with Amendment 1.

All qualification tests, lot conformance, periodic conformance inspections, and capability verification inspections must be performed at facilities which have DLA Land & Maritime-VQ Laboratory Suitability Status for each of the applicable test methods.

Note: The results of the DLA Land & Maritime-VQE validation audit held on March 30 through April 1, 2010, were found by examining a sampling of the manufacturer's normal manufacturing, testing, and processing procedures. The acceptance of the corrective actions from the above referenced validation audit does not relieve the manufacturer of its contractual obligation to deliver printed boards that comply with all applicable requirements.
